



Opinion:

6)Trade payable ratio has increased slightly on account of increase in creditors at year end.

7)Net capital turnover ratio has increased on account of efficient use of short term assets and liabilities for supporting sales.

8)Net profit ratio has increased slightly.

9) Return on capital employed has increased slightly on account of increase in sales and reducing the cost.

10) Return on investment has increased on account of increase in Fixed deposit by company.
