**"RESOLVED THAT** in furtherance of the resolution passed by the Board on December 17, 2024 and the resolution passed by the shareholders of the Company on December 18, 2024, subject to and in accordance with the applicable provisions of the Companies Act, 2013, and the rules made thereunder, each as amended, the applicable provisions of the Securities and Exchange Board of India Act, 1992, as amended, the Securities and Exchange Board of India (Issue of Capital and Disclosure Requirements) Regulations, 2018, as amended ("**SEBI ICDR Regulations**"), the Securities Contracts (Regulation) Act, 1956, and other regulations issued by the Securities and Exchange Board of India ("**SEBI**"), the draft red herring prospectus dated December 27, 2024 ("**DRHP**"), in respect of the initial public offer of such number of Equity Shares up to an aggregate amount of up to ₹ [●] million, consisting of a fresh issue of such number of Equity Shares up to an aggregate amount of ₹ 6,000 million (including share premium) ("**Fresh Issue**") and by way of an offer of sale of up to 7,874,015 Equity Shares by Pragnyat Lalwani and Gautam Jain, ("**Promoter Selling Shareholders**") ("**Offer**"), at such price as may be determined in accordance with the book building process under the SEBI ICDR Regulations and as determined by the Company in consultation with the BRLMs to the Offer, as provided to the Board of Directors, containing the requisite information as prescribed by applicable laws and regulations, the DRHP as provided to and placed before the Board of Directors be and is hereby approved and adopted for filing with SEBI, the BSE Limited, the National Stock Exchange of India Limited ("**Stock Exchanges**") and such other authorities or persons as may be required, subject to it being duly signed by the directors of the Company, chief financial officer and the Selling Shareholders (or their duly authorized representatives).

**"RESOLVED FURTHER THAT** any member of the Board and/or the Company Secretary and Compliance Officer and the Chief Financial Officer of the Company, be and are hereby severally authorised to finalise the DRHP and submit the same with SEBI, the Stock Exchanges and such other authorities or persons as may be required, issue such certificates and confirmations as may be required, settle any questions or clarifications that may arise and undertake such other necessary steps to implement the above resolution."

**"RESOLVED FURTHER THAT** the Directors of the Company and the Chief Financial Officer of the Company, be and are hereby authorized to sign the declaration pages of the said DRHP for and on behalf of the Company and file the same with SEBI for their observations and with the Stock Exchanges for obtaining their in-principle approval and for listing purposes and such other authorities or persons as may be required, and undertake such other necessary steps to implement the above resolutions."

**"RESOLVED FURTHER THAT,** the IPO Committee is hereby authorized to undertake, approve and adopt any subsequent changes, correction, updates, alterations, revisions, modifications or amendments in the DRHP in accordance with the applicable law and regulations prior to filing with the SEBI including to determine the number of shares and/or the amount proposed to be raised."
